PROCLAMATION NO. 06

DECLARING WEDNESDAY, 6 JULY 2016, AS A REGULAR HOLIDAY THROUGHOUT THE COUNTRY IN OBSERVANCE OF EID'L FITR (FEAST OF RAMADHAN)

WHEREAS, Republic Act No. 9177 declared Eid'l Fitr (Feast of Ramadhan) as a regular holioay throughout the country;

WHEREAS, Eid'l Fiti is celebrated by the Muslim world for three (3) days after the end of the month of fasting;

WHEREAS, the entire Filipino nation should have the full opportunity to join their Muslim brothers and sisters in peace and harmony in the observance and celebration of Eid'l Fitr, and

WHEREAS, in order to bring the religious and cultural significance of the Eid'l Fitr to the fore of rational consciousness, it is necessary to declare Wednesday, 6 July 2016, as a regular holiday throughout the country.

NOW, THEREFORE I, RODRIGO R. DUTERTE, President of the Philippines, by virtue of the powers vested in me by law, do hereby declare Wednesday, 6 July 2016, as a regular holiday throughout the country in observance of Eid'l Fitr (Feast of Ramadhan).

IN WITNESS WHEREOF, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.
